

Dear SDSEO Member:

The last week of the session starts Monday. The state employee compensation and health budget will be set, probably Tuesday, though it could be later, depending. Right now the Joint Committee on Appropriations has all the big budgets set for Tuesday. Here is their agenda for that day; state employee compensation and health will be under the Bureau of Finance and Management budget: https://mylrc.sdlegislature.gov/api/Documents/266989.pdf. They will also set budgets on Monday: https://mylrc.sdlegislature.gov/api/Documents/266986.pdf. Hearings the last week usually have lots of breaks, as lawmakers hash things out amongst themselves and in party caucus, so it won't be all in a straight line or necessarily orderly.

There's nothing you need to do push. The governor, any state's single most powerful voice for or against state employees, is for you. Here's a news excerpt from this week: "Noem explained that budget has been the most important thing this session and that lawmakers have spent a lot of time preparing for budget requests and making sure South Dakota's dollars were being put in the appropriate places to benefit the state long term. These budgets primarily focus on state employees, education, and care providers. Noem stated that she added a four percent increase this year and that if there were additional funds left over she would put it toward South Dakota prison facilities, an improvement she's seen a need for since her first term. 'I could not believe that we had facilities that were so outdated and that we had people in those conditions,' said Noem. She continued, 'One of our prison facilities needs upgrades or to be rebuilt, and the fact that this legislature sees that priority I'm very grateful for.'" The story link for that quote is here.

All of the SDSEO's funding comes from membership; outfits like this receive zero state or federal dollars or incentives or tax breaks. While so much of the non-profit universe is focused on 501c(3) charities that were created to seek donations and then give the funds away to hard-pressed folks either in the form of cash or in the form of services, professional and labor non-

profits such as the SDSEO are important too. Non-profit organizations like the SDSEO exist to help create and maintain healthy careers and service, hopefully keeping charities in the business of providing aid to the hardest pressed. That's why charities have tax-free donation and deduction status and organizations like the SDSEO do not.

Make sure to spread the word about the SDSEO and encourage membership. You're likely going to go out with co-workers on lunch or after work: Maybe offer to pay for their lunch that one time (you're probably going to anyway at some point, since you're a South Dakotan) and encourage them to join the SDSEO, which likely costs less than 1 work lunch a month.
